WARRANTY CERTIFICATE

Chrisleo Pty Ltd Pvt Limited provide the following limited warranty to the original retail owners of Viking WEST 590 PRO and THUNDER 460 boat, subject to the remedies, exclusions, and limitations set out below, that if boat operated under normal, non-commercial use, the selling dealer will repair or replace, at its sole discretion, any defect in material or workmanship in the “**West 590 pro and Thunder 460**” Boat that is reported within the applicable warranty periods.

1. Limited One (1) year Structural Hull/Deck Warranty to Original Owner: Any Structural Hull/Deck Defect in fiberglass material or workmanship which is reported during the period of ownership by the original retail owner of the Boat will be repaired at builder sole discretion. The “Hull” shall mean the single fiberglass melded shell and integral structural components. The “Deck” shall mean the moulded fiberglass shell and integral fiberglass structural components of the floor. A Structural Hull/Deck Defect shall mean a substantial defect in the **West 590 pro Boat and Thunder 460 Boat’s** Hull/Deck which causes the boat to be unfit or unsafe for general use as a pleasure craft under normal operating conditions. If boat is Damaged with any external effect on the boat other than defect in material of Workmanship the Warranty would be applicable.
2. Limited one Year Structural Hull/Deck Warranty to Second Retail Owner: Upon the second owner’s receipt of an approved warranty transfer from Viking boat will repair at its sole discretion any Structural Hull/Deck Defect in fiberglass material or workmanship on the Sport Boat reported within one (1) year of the date of the first retail purchase.
3. Limited One Year Laminate Hull Blister Warranty: Repair any gel coat surface of the Hull that has laminate blisters which occurred as a result of a defect in material or workmanship and is reported within One (1) years of the date of delivery to the original retail owner This One-Year Limited Hull Blister Warranty is voided in the event the original factory gel coat is altered by damage, accident repair, sanding, scraping, sandblasting or improper preparation for marine bottom paint. This warranty will also be voided as a result of in-water storage without a marine barrier coating properly applied to the hull bottom. This One-Year Limited Hull Blister Warranty is not transferable.
4. Limited One Year Cosmetic Exterior gel coat Warranty: Repair stress cracks, crazing, air voids or other cosmetic defects in the exterior gel coat finish of the hull and the deck resulting from defective materials or workmanship. Because local environmental conditions and customer care have an effect on gel coat finishes, the gel coat finish warranty does not include damage or deterioration (i.e. fading, oxidation, discoloration) due to in-water storage or improper care of the gel coat surface; or deterioration (i.e. fading, oxidation, discoloration) to the gel coat finish on any boat with colored (non-white) gel coat located below the waterline
5. Limited Warranty on Specific Parts: Repair or replace any parts, not covered by the limited warranties referenced above or excluded in What is Not Covered, which are defective in factory material or workmanship and reported within one (1) year of date of delivery to the owner. original retail
